The chief judge will assign each appeal to a district judge to hear pursuant to local court rule.

**ADMINISTRATIVE ORDER NO. 07-13
ORDERS SUBMITTED TO CLERK'S OFFICE**

When a party submits any document to the Clerk of the District Court for filing that the clerk receiving the document reasonably believes is an order, decree, or journal entry that needs to be signed by a judge, the clerk shall give the document to the judge presiding over the case to review before filing the document in the case file. In the event that the presiding judge is not available the clerk shall submit the document to the chief judge for reassignment pursuant to Local Court Rule Number 1. At the time the document is received the clerk shall inform the party submitting the document that the document must be reviewed and approved by a judge before it will be filed in the case. The document shall be filed in the case file only if the reviewing judge finds that it is a document appropriate for filing in the case file. If the judge determines that the document is not appropriate for filing the judge or his or her administrative assistant shall return the document to the party attempting to file the document.
