**ORDER OF APPOINTMENT PURSUANT TO KANSAS SUPREME COURT RULE 221**

Now on this 21<sup>st</sup> day of August, 2019, the Chief Judge of the 7<sup>th</sup> Judicial District being duly informed of the incapacity of Janet McKillip, an attorney whose primary office is located in Douglas County Kansas, does hereby appoint Todd B. Butler, Kansas Bar #12711, pursuant to Supreme Court Rule 221 (2019 Kan. S. Ct. R. 276), to review and inventory the attorney's client files and the attorney's trust account and take such action, including the distribution of funds, as may be necessary to protect the interests of the attorney or her clients.

Todd B. Butler is authorized to delegate various legal duties to other attorneys within his law firm. Pursuant to Supreme Court Rule 221(b), the attorney and his associates shall not disclose any information contained in the client files except as necessary to carry out the order of this court.

The immunity set forth in Supreme Court Rule 223 (2019 Kan. S. Ct. R. 278) shall be afforded to Todd B. Butler and his law associates in the performance of the responsibilities set forth in this order. Todd B. Butler is further authorized to access the attorney's trust account and to take any action deemed to be necessary to protect the interests of the clients.

Appointed counsel affirms that he is a licensed practicing attorney in the State of Kansas.


This appointment pursuant to Supreme Court Rule 221 grants the Appointee all rights and responsibilities necessary to protect the interests of the legal practice and the clients of the legal practice. This includes but is not limited to the following duties:

1. Inventory all legal files and determine the status of each file.
2. Inform all clients of their legal options.
3. Obtain a financial accounting of each legal file.
4. Negotiate any checks which may be payable to her legal practice for legal services.
5. Withdraw, deposit, and disburse any funds necessary to properly maintain the IOLTA trust account until the same is closed.
6. Withdraw, deposit, and disburse any funds necessary from the business operating account(s) as required to timely conclude all legal and administrative work of the legal practice until such time as this appointment is rescinded and/or the attorney's practice is closed
7. Update the Chief District Judge every 90 days from the date of appointment on progress.
8. Receive mail related to Janet McKillip's legal practice.
9. Receive all passwords related to her Janet McKillip's practice.

The appointment shall be for a period of no longer than nine months and the Appointee shall provide the Chief Judge with a final accounting at the end of three months, unless an extension of the period of appointment is requested and granted.
