

**VENDORS FIREWORK PERMIT REQUIREMENTS  
FOR THE  
UNINCORPORATED TERRITORY FOR DOUGLAS COUNTY, KANSAS**

This stand is properly registered with the Douglas County Zoning Administrator and permission has been granted for the sale of Fireworks on the July 1st, 2nd, 3rd, and 4th days of July 2015. Subject to the Following Conditions:

- (A) No shooting of fireworks shall be permitted within one hundred (100) feet of the fireworks stand.
- (B) A temporary stand shall be located at least twenty-five (25) feet from road or highway rights of way.
- (C) Off street parking must be provided for employees and customers.
- (D) Weeds and grass must be cut back within one hundred (100) feet of the stand.
- (E) The stand may not be located in any area where its proximity to other explosive materials or flammables will create safety hazards.
- (F) Only one 32 SQ. FT. Fireworks advertising sign erected in the front of stand located off the road or highway rights-of-way. Each stand shall have a 3 foot by 3-foot sign visible to the public for posting of rules.
- (G) The temporary stand and signs shall be removed on or before the 8th day of July.
- (H) Sales or other distribution of fireworks, under the permit, shall be limited to fireworks authorized under the laws of the State of Kansas, with the exception that the sale or other distribution of fireworks known as bottle rockets is prohibited.
- (I) Each fireworks stand temporarily erected to be used as a place for storing and selling fireworks shall have at least two (2) fire extinguishers and a cellular phone in case of emergencies.
- (J) Any stand, which gains its principle means of ingress/egress by crossing the hike and bike path, shall post a \$1,000.00 refundable bond. The bond shall be made payable to Douglas County.

All application for fireworks stand permits shall be accompanied by a drawing showing the following information:

- (a) Name of stand, name, and address of property owner and operator of stand.
- (b) Legal description of property where stand is to be located.
- (c) Location of stand from road or highway rights of way.
- (d) Showing parking area for customer
- (e) If a sign will be used to advertise the stand, show the location and size of sign.
- (f) Copy of Sales Tax certificate.

**AN INSPECTION OF THE SITE FOR THE FIREWORKS STAND MAY BE REQUIRED PRIOR TO ISSUING THE PERMIT.**

**\*\*\*Douglas County Home Rule Resolution No. HR-07-6-4 \*\*\***

It shall be unlawful to ignite, explode or use any fireworks in the unincorporated area of Douglas County, Kansas except from 7:00 A.M. to 10:00 P.M. on July 1st and 2<sup>nd</sup> in any year and from 7:00 A.M. to 12:00 Midnight on July 3<sup>rd</sup> & 4<sup>th</sup> in any year.
